COMMENTS: The two treatable-rehabilitatable dogs that were euthanized were euthanized without my consent. They were two underage puppies that were exhibiting some neurological problems. One vet told me that because of their age (only 2-3 weeks old) and the poor conditions of the environment they came from, that their condition should resolve given time. The puppies were left in the care of the animal hospital. The other vet on staff thought the condition would not resolve and euthanized the pups the next day without consulting me or the other veterinarian. I don't know whether or not their condition would have been resolved, so I don't truly know what their classification should have been. What I do know is that these puppies were not given the chance that they deserved... and I no longer use this veterinary hospital because of that.
